County Budget Impacts FY2013-2014---Including Lost Revenue Sharing and Hold-Harmless Payment

1 - Continues to shift funds from HURF to DPS outside of the Statutory limit.

2 - As FY14 session law, the reimbursement percentage for counties drops from a 50/50 split to an estimated 35/65 split for the commitment of an

individual determined to be a sexually violent person and confined in the Arizona Community Protection and Treatment Center (ACPTC). This reduction is

to be accomplished by having the Department of Health Services (DHS) determine a percentage to be reimbursed by counties that increases the state

cost (and therefore reduces the county cost) by \$1.8 million). Based on actual billings during FY13 (thru May) and revised down, proportionally, to adjust

for the \$1.8 million reduction. Actual charges will vary depending on caseload.

3 - Based on actual case billings from FY13 (thru May). Estimates assume FY14 charges will be the same, actual charges will vary depending on caseload. Does not include any amount a county pays for an outside provider.

4 - Starting in FY11, the state share of Justice of the Peace salaries is permanently lowered from 38.5% to 19.25%.
5 - No State appropriation was included in the budget.

6 - Originally eliminated in FY11, the FY14 budget includes a direct appropriation \$7.2M (\$550,000 each) to counties under 900,000 persons.

7 - County Hold Harmless was eliminated in FY11

Note: Additional ongoing impacts not quantified include:

- Elimination of Post-Conviction Public Defender's Office
- Elimination of Department of Health Services' grants to counties (Prenatal, Tuberculosis, influenza, food borne illness)
- Suspension of State Lake Improvement Fund (SLIF) grant program
- Reduction of Federal Resources (Secure Rural Schools, Payment In Lieu of Tax, Criminal Justice, Public Health, among
