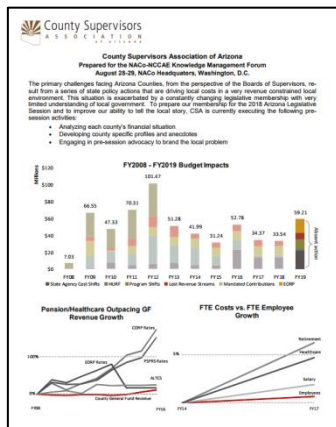

NACo-NCCAE Knowledge Management Forum



This week, CSA staff participated in the National Association of Counties (NACo) and National Council of County Association Executives (NCCAE) Knowledge Management Forum in Washington, D.C.

During the event, CSA staff presented on the impact of state policy decisions that are driving local costs in very revenue constrained local environments. They shared information on county budget impacts, slow long term revenue growth, and property tax revenues.

Other presentations during the event addressed service sharing between government entities, county services provided to low income families, rural broadband developments, and the impact of a retiring county workforce.

The NCCAE provides a vehicle through which its membership improves the administration of the various associations of counties and associations of county officials, and provides a forum through which members meet and exchange information of importance. Additionally, it assists, in accordance with the policy determinations of the council, the National Association of Counties in its efforts to promote and improve county government.
