The 2016 Primary Election took place on Tuesday, August 30.

One U.S. Senate seat and all nine congressional seats are up for grabs this November, as are the 90 state legislative seats and all 61 county supervisor positions.

Ballot Measures on Marijuana and Minimum Wage Moving Forward



After considering various legal challenges, the Arizona Supreme Court will allow voters to decide on two ballot proposals this November in the General Election.

Proposition 205: Regulate Marijuana Like Alcohol in Arizona, seeks to regulate marijuana by establishing a 15 percent tax on retail marijuana sales, for public health and education. If the measure passes, adults, 21 years of age and older will be allowed to possess, privately consume, and grow limited amounts of marijuana. The measure creates a system in which licensed businesses can produce and sell marijuana. Additionally, the proposal establishes a state Department of Marijuana Licenses and Control to regulate the cultivation, manufacturing, testing, transportation and sale of marijuana in the state. The measure does provide local governments with authority to regulate and limit marijuana businesses.

Proposition 206: Arizona Minimum Wage and Paid Time Off, seeks to incrementally increase the state minimum wage, first to \$10 in 2017 and then to \$12 by 2020. It also seeks to require paid sick time for employees of both large and small employers (time varies based on size of employer).

On August 29, 1912, a new state law required that every owner a motor vehicle pay \$5 per year for a license.

The first license was issued to Dr. Hiram Fenner of Tucson. Dr. Fenner's locomobile steam car was Tucson's first car arriving in December of 1899. The vehicle cost him \$600 with an added shipping fee of \$200.
