## Supervisor McCloud Participates in NACo PILT Fly-in

Yuma County Supervisor and CSA Second Vice President, Russell McCloud, participated in the Annual NACo Payment in Lieu of Taxes (PILT) Fly-in. The fly-in took place on September 9-11, in Washington, D.C., with county officials from across the country visiting Capitol Hill to advocate for continued full funding of the PILT program.

In 1976, Congress enacted the Payment in Lieu of Taxes (PILT) Act, acknowledging the county role in stewardship of public lands – and the federal government's responsibility to compensate counties for the cost. The PILT funding is critical to Arizona's counties and only partially compensates for the fact counties can't collect

property taxes from federally owned lands, yet still must provide services to these areas, which included, law enforcement, search and rescue, firefighting, and other community services.

The Gila River swelled to more than 4 miles in width, destroying everything in its path. Tucson's new courthouse, completed only a few months earlier, was seriously damaged, with its walls split and roof leaking.


