#### CSA Legislative Priorities: If it prints front and back, it's still a "one-pager"!

Last month, the CSA Board of Directors adopted its priorities for the 2019 legislative session. The <u>linked document</u> briefly outlines CSA's objectives and policy proposals.


Top of the list is to complete the work from last session related to major state cost shifts and spikes in pension liability. In FY19, state leaders did a great job addressing county financial issues and counties encourage law-makers to make the relief permanent in FY20 and beyond.

Specifically, counties are counting on state leaders to eliminate the mandated county fee to support the Arizona Department of Juvenile Corrections and to provide permanent relief for the increased liability associated with the Elected Officials Retirement Plan.

Counties also encourage the state to take action in the wake of the U.S. Supreme Court's Wayfair decision, which removes the major barrier for states to tax on-line transactions and to promote tax fairness between main-street and on-line retailers.

Additionally, CSA will continue to participate in a coalition of public and industry associations to encourage increased investment in transportation infrastructure and will work to advance 5 county-submitted policy proposals.

## Arizona Courts Committee on Mental Health and the Justice System Meets

The Committee on Mental Health and the Justice System (Committee) was established by an administrative order of the Arizona Supreme Court in August 2018, based on recommendations from the Task Force on Fair Justice. The Committee has been tasked with identifying and recommending ways to address the issues faced by individuals with mental and behavioral health needs within the justice system.

During the Committee's second meeting held on Tuesday, October 30, 2018, the discussion focused on: their scope of work, the need to establish workgroups, and the importance of spending an appropriate amount of time on each step of the Sequential Intercept Model. The Committee plans to determine the focus of each workgroup prior to the next meeting scheduled for November 29, 2018.
