## Supervisor Archuleta Testifies Before U.S. Senate Committee

On June 18, 2019, Chairwoman Murkowski (R, AK) convened the Senate Committee on Energy and Natural Resources for a full committee hearing to “examine deferred maintenance needs and potential solutions on federal lands administered by the Department of the Interior and the USDA Forest Service.” Coconino County Supervisor Elizabeth Archuleta testified on behalf of the National Association of Counties, urging Congress to enact legislation to bring deferred maintenance to sustainable levels in order to better serve visitors to public lands and parks. Supervisor Archuleta was joined by testimony from the Department of the Interior, the USDA Forest Service, the Public Lands Alliance, and the recreational industry.

## County Managers Meet



The County Managers/Administrators Association was provided an update from staff on the proposed assumption changes that the new Public Safety Personnel Retirement System (PSPRS) actuary has proposed for all PSPRS and CORP plans. For many counties, the plan's have significantly underperformed the current assumptions, meaning future year employer costs will have to increase to properly fund the plans under the new assumptions.

Staff also provided an overview of the Arizona Long Term Care System (ALTCs), which counties and the state contribute funding towards for the long term care services to Arizona's elderly and physically disabled populations. System growth along with legislative changes to increase provider payments drove up the total county contribution by 8.1 percent from FY 2019 to FY 2020. Managers and administrators also looked at trends in county-specific enrollment and utilization in ALTCs over the past decade.

## Yavapai Sheriff's Office Presentation at Managers Roundtable

Last Thursday, county managers and professional staff attended a presentation by Yavapai County Sheriff Chief Deputy David Rhodes and Executive Director of Yavapai Justice & Mental Health Coalition Beya Thayer on the Yavapai County Sheriff's Office response to mental health and drug abuse in the justice system.

Chief Deputy Rhodes noted they used the six questions outlined in the Stepping Up Initiative's framework to help guide their process. The six questions include:

- 1) Is your leadership committed?
- 2) Do you have timely screening and assessments?
- 3) Do you have baseline data?
- 4) Have you conducted a comprehensive process analysis and service inventory?
- 5) Have you prioritized policy, practice and funding?
- 6) Do you track progress?



Chief Deputy Rhodes and Thayer discussed the importance of bringing together the different areas that have a touchpoint with individuals experiencing mental illness and drug abuse and the need to establish wrap around services that address the basics such as food, transportation and housing. They also noted prioritizing an understanding of the system as a whole through information sharing has enabled decisions to be evaluated to see if the intended outcome was achieved and provides an opportunity to assess the need to modify existing processes to improve results.

## Governor's Water Council Convenes – New Work Groups Created

The Governor's Water Augmentation, Innovation and Conservation Council met at ADWR on June 13. The 41 member council, chaired by Arizona Department of Water Resources (ADWR) Director Tom Bushatzke, is charged with evaluating opportunities to secure a sustainable water future in the state. CSA holds a seat on the council.



At the meeting, existing workgroups related to long-term water augmentation and desalination reported their progress, and ADWR staff presented their findings from a water loss study conducted on a sample of small water systems and reported on the status of the Active Management Area (AMA) plans.

Very importantly, Director Bushatzke announced the formation of two new work groups. The Management Plan Work Group was created as a stakeholder forum for the development of the AMA's Fifth Management Plans, with a goal of working to assess existing AMA conservation programs and to develop new management strategies for the 5th management period and beyond. Tim Thomure, Tucson Water, and Warren Tenney, Arizona Municipal Water Users Association (AMWUA), will chair the effort.

Also established, a Groundwater Committee charged with evaluating issues in areas outside of the AMA's. Representative Gail Griffin and Jamie Kelley, Mohave County Water Authority, stepped up to co-chair this group.

## JLBC Monthly Fiscal Highlights

On Thursday, Joint Legislative Budget Committee (JLBC) staff released their monthly summary of the state's general fund revenues and expenditures. May was a record month for general fund revenues, with collections at \$1.2 billion, 48.1 percent above May 2018. JLBC staff noted that this is largely due to a shift in large Individual Income Tax (IIT) payments from prior months to May. Over the past several months, IIT revenues have come in under forecast and were instead captured and processed in May. Additionally, the effects of conforming to the federal tax code for Tax Year 2018 have also contributed to the higher-than-forecasted revenue performance in IIT payments. High sales tax and IIT collections put year-to-date general fund revenues 11.6 percent above the same period in FY 2018, and \$183.8 million above the recently enacted budget forecast.

Year-to-date the Highway User Revenue Fund (HURF) has collected 1.4 billion in revenue for transportation which is 4.2 percent above the previous year and 1.7 percent above the JLBC baseline forecast.

## Wildfire Update

Effective Friday, June 21<sup>st</sup> the Department of Forestry and Fire Management implemented Stage 1 fire restrictions on Arizona state-owned and managed lands in Gila, La Paz, Maricopa and Yuma Counties and parts of Mohave County, for more information on the restriction please click [here](#).

Stage 1 includes the following restrictions and prohibitions:

- Fires, campfires, charcoal, coal, or wood stoves, other than in a developed campsite or picnic area;
- Smoking, except in specified locations;
- Fireworks or another incendiary device; and
- Welding or operating acetylene or other torch devices with an open flame.

County leaders have deployed resources to protect public safety in communities threatened by wildfires. There are currently three wildfires and three prescribed fires burning throughout Arizona, which include:

- Woodbury Fire – is burning five miles north of Superior, Arizona. The fire has reached 65,903 acres and is currently only 42% contained. The cause of the fire is unknown, but there are over a thousand people working to contain it. The fire has forced residents in the Roosevelt and Roosevelt Lake area to evacuate. The hot dry conditions and strong winds continue increase the rate at which the fire is spreading.
- Maroon Fire – caused by lighting, the fire is burning 18 miles northeast of Flagstaff off Leupp Road near Maroon Crater, and has consumed 8,206 acres. The fire is currently 80 percent contained.
- Coldwater Fire – the fire has burned 16,790 acres since started by lighting on May 30<sup>th</sup>, but is now 90% contained. The fire is located approximately four miles south of Clints Well and one mile east of state Route 87.
- Kaibab NF North Zone RX Fire – a prescribed fire of about 1,436 acres consisting of two prescribed burns, fire managers are monitoring the fire to ensure it stays contained within the designated areas.
- Long Jim I and III – a prescribed fire of about 1,761 acres is adjacent to the South Rim, the fire is burning pine and juniper and scheduled to treat 2,849 acres.
- Kaibab NF South Zone RX Fire – multiple prescribed fires within the Williams and Tusayan Ranger Districts are planned, fire managers are working to minimize the impact of smoke to communities and closely monitoring the fires. There are three main prescribed fires in the Kaibab NF South Zone:
  - Russell Fire: is scheduled to start June 24<sup>th</sup>, weather permitting, and is scheduled to burn 2,130 acres about 13 miles southeast of Tusayan;
  - Sunflower Fire: burned about 2,803 acres south of Williams, fire crews are monitoring the project as the project wraps up.
  - Reed Fire: a total of 1,403 acres have been completed near Tusayan and operations may resume in coming weeks.
