ADOA State Compliance and Privacy Officer, Owen Zorge, provided a thorough overview of the types of cyber security threats facing public entities and resources available to local governments to address cyber security issues.

Additionally, Ed Jimenez, State Procurement Administrator at ADOA, provided a look into the state's new procurement system, the Arizona Procurement Portal, and the offices' efforts to streamline procurement for the state.

## 79<sup>th</sup> Annual Arizona Tax Research Association (ATRA) Conference



The 79<sup>th</sup> Annual Arizona Tax Research Association (ATRA) Conference was held on Thursday in Scottsdale to discuss major tax issues facing the state and what to expect for tax policy discussions in the upcoming legislative session.



Director of the Governor's Office of Strategic Planning and Budgeting Matt Gress presented a report on the current status of the economy and the State's fiscal picture. Generally, Gress's view is that the economy is strong and that things are looking up for the state, considering the General Fund has the largest ever cash reserves in history and revenues continue to be strong each year. Although Gress indicated existing revenue growth is unlikely to continue at its existing rate indefinitely, data suggests 2020 will be a strong year with continued growth thereafter. Finally, Gress stated that the Governor's budget is expected to be nearly completed as of Friday, the earliest ever, with intentions of passing the budget quickly this session.

Additionally, House Speaker Rusty Bowers, Senate President Karen Fann, and Senate Minority Leader David Bradley participated in a legislative roundtable, discussing what challenges the Legislature is facing and what to expect from the upcoming legislative session. The panel indicated that budget discussions are already underway and that the hope is for a quick budget passage and overall session. President Fann stated the preliminary Senate budget is well under way, and the expectation is that the budget would be voted on and completed during the week bills transition from their originating chamber to the other (typically around the end of February). She also stated that, if the budget cannot be completed that week, the intention is to halt all other business until the budget is completed.

Other discussion at the conference included an update on major tax policy issues by ATRA staff, as well as an update on pending tax cases impacting Arizona taxpayers and policymakers.

## Interim Legislative Meetings

### Senate and House Commerce Committee of Reference (Committee)



The Committee met to discuss the sunset review of the Arizona Department of Gaming (Department). The Arizona Office of Auditor General (OAG) completed their initial sunset review and performance audit in August of 2018. The audit evaluated the Department's compliance statutory requirements for regulating the Arizona Tribal-State Gaming Compact (Compact) and horse racing licensure.

Since the initial audit the Department has implemented seven of the twelve recommendations, is in the process of implementing three recommendations, and two recommendations are not yet applicable. The OAG will conduct an 18 month follow up with the Department on any recommendations not yet fully implemented.

The Committee made a recommendation to continue the Department for 4 years to align with the expiration of the existing Compact and to align the Department's new statutory requirement to regulate boxing, mixed martial arts, and racing.

### House Ad Hoc Committee on Abuse and Neglect of Vulnerable Adult (Committee)

Tuesday, November 12, 2019 the 13-member Committee met to discuss potential recommendations to be included in a report accompanying the findings from the Governor's Abuse and Neglect Task Force. Some of the issues addressed included the implementation of an oversight group, statutory changes to define abuse including protection from emotional abuse, trauma informed investigations, and creation of a whistleblower statute.



The Committee is set to meet again on December 17<sup>th</sup> where they will review a draft of the report and recommendations.

### House Ad Hoc Committee on Groundwater Supply in Pinal County (Committee)



On Wednesday, November 13, 2019 the 7-member Committee charged with studying the supplies of available groundwater and the renewable supplies in Pinal County met.

The Committee heard testimony from the Pinal AMA Water Supply Stakeholder Group (Pinal Stakeholder Group) created by the Committee in October. The Pinal Stakeholder Group recommended expanding membership to include local government, local utilities, local communities, agriculture developers, economic organizations, the Arizona Department of Water Resources and the Pinal Indian Community and noted they will have a kick-off meeting in December.

### Senate Ad Hoc Committee on Minimizing Contaminant Risk & Exposure for First Responders (Committee)

On Thursday, November 14, 2019 the Committee met to hear testimony regarding cancer screening and prevention for first responders.

Captain Crogan and Captain Figgins from the Mesa Fire and Medical Department shared some best practices to reduce the transfer of carcinogenic materials to first responders, methods of cancer prevention, and types of cancer screening procedures currently used by his department.

The Committee is set to meet again in December where they will be discussing possible recommendations.
