The 2016 Primary Election takes place next Tuesday on August 30.

One U.S. Senate seat and all nine congressional seats are up for grabs, as are the 90 state legislative seats and all 61 county supervisor positions.



JLBC Monthly Fiscal Highlights

This week, the Joint Legislative Budget Committee (JLBC) released the monthly fiscal highlights for July, the first month of the new fiscal year. Total General Fund collections in July totaled \$660.4 million, \$(42.2) million below July 2015 and \$(15.8) million below the budget forecast. July follows up the disappointing collections in June which were also below forecast. The primary culprits in the



The poor performance of the income tax categories was partially offset by a healthy sales tax growth. Sales tax collections in July totaled \$17.2 million, a 4.9 percent increase over July 2015, and \$7.9 million over forecast. This is a good piece of news for the sales tax collections which, other than the June numbers, has seen slow growth over the past fiscal year.

Highway User Revenue Fund (HURF) collections continue to be a bright spot with July collections totaling \$118.7 million, a 5.8 percent increase over July 2015, and \$4.5 million above forecast.

This Week in Arizona History...


