OSPB Director Talks with County Managers

Today, the Director of the Governor's Office of Strategic Planning and Budgeting (OSPB), Matt Gress shared insights with the county managers about the status of the Arizona State budget and the outlook going forward.

Gress noted that State General Fund revenues beat expectations in 2018 and are projected to do so in 2019 as well, but the Governor's Office continues to exercise fiscal restraint to protect resources long term. He discussed the Governor's priorities of both K-12 Education and public safety in the coming legislative session.

Gress also explored a variety of indicators that demonstrate the strong position Arizona is currently in, including population growth and job growth.

On Monday, CSA was pleased to host its annual County 101 presentation and roundtable with legislative staff. More than 40 attendees from legislative staff offices from both chambers joined the discussion, including: Senate minority, Senate research, House majority, House minority, and House majority research staff.



CSA's Legislative Research Program Manager, Robin Hillyard kicked off the event by sharing the importance of the partnership between county government and the legislature as well as the invaluable work of the legislative staff at the state legislature. Kristin Cipolla, Senior Legislative Liaison and Brandon Nee, Budget and Fiscal Analyst, also presented.

The roundtable examined the role of CSA, the importance of county government, CSA's legislative package and the challenges ahead in 2019.

2018 Midterm General Election Results Canvassed

On November 6, 2018 Arizonans went to the polls to vote for a variety of officials, including a U.S. Senator, nine congresspeople, state-wide officers, and local and judicial officials.

On December 3, 2018, Secretary of State Michelle Reagan [canvassed](#) the results. The Secretary was joined by Governor Doug Ducey, Attorney General Mark Brnovich and Chief Justice Scott Bales for the formal certification.

"2.4 million Arizonans voted in the general election," said Secretary Reagan. "Turnout for the 2018 midterm was a full 17 points higher than our previous midterm and highest it has been in 36 years. Between the General and the Primary, 3.62 million votes were cast. Coconino, Gila, Maricopa, Pima, and Yavapai all had the highest turnout percentage of any midterm on record."

NACo High Performance Leadership Academy Open Enrollment

The National Associations of Counties (NACo) in association with the Professional Development Academy created a 12-week mentorship-based leadership program to empower frontline county government professionals. Participants spend 3-5 hours a week engaged in an online, interactive learning platform to engage in live events, video sessions and breakout group discussions.



The curriculum developed by the Professional Development Academy in a partnership with Fortune 1000 executives, public sector leaders, world-renowned academics and thought leaders, including General Colin Powell and Dr. Marshall Goldsmith, focuses on five essential skills:

- **LEAD:** Engage teams and stakeholders to foster positive climates and exceed common expectations
- **ORGANIZE:** Plan, lead and execute organizational change more effectively and consistently
- **COLLABORATE:** Establish alignment and strong partnerships through building stronger relationships
- **COMMUNICATE:** Create clarity, confidence and community
- **DELIVER:** Measure projects and processes to deliver results aligned with county and community priorities

NACo secured a discounted rate of \$1,495 per enrollee for members; additionally NACo will provide a \$1,000 one-time stipend for the first participant in each county to subsidize the discounted rate. The next course will start on January 7, 2019 with subsequent classes planned for April and August of 2019.

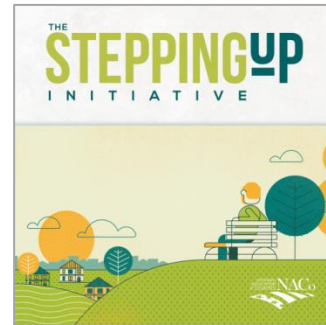
