## NACo PILT Fly-In



CSA President and Yuma County Supervisor Russell McCloud, Greenlee County Supervisor Richard Lunt and Gila County Supervisor Woody Cline participated in the annual NACo Payment in Lieu of Taxes (PILT) Fly-in. The fly-in took place this week in Washington, D.C. with county officials from across the country visiting Capitol Hill to advocate for fully funding the PILT and Secure Rural Schools (SRS) programs in FY 2020 and beyond.

Counties stand to lose more than \$39.9 million if Congress does not act to meet its commitment to public lands counties in the 2020 budget. PILT funds support mandated essential county services associated with public lands, including law enforcement, road maintenance and search and rescue services.

A House Appropriations Act ([H.R. 3055](#)) fully funds the FY 2020 Payment in Lieu of Taxes (PILT). The bill has passed the United States House of Representatives and awaits action by the United States Senate.

To help stop the annual uncertainty of whether the federal government will meet its PILT funding commitment, U.S. Representative Ann Kirkpatrick (AZ District 2) introduced [H.R. 3043](#) on May 30<sup>th</sup>. The bipartisan legislation would permanently authorize the PILT program. H.R. 3043 would help bring assurance to local governments, eliminating the uncertainty of the annual budget appropriation process. The bill has not had any additional action since being introduced May 30, 2019.

In 1976, Congress enacted the PILT Act, acknowledging the county role in the stewardship of public lands – and the federal government’s responsibility to compensate counties for the cost. PILT funding is critical to Arizona’s counties and only partially compensates for the fact that counties cannot collect property taxes from federally owned lands, yet still must provide basic government services.

## County Managers Meet



Today, at the County Managers and Administrators monthly meeting, Director of the Administrative Office of the Courts Dave Byers provided a briefing on the recent probation officer salary increases and general court funding. In addition, Byers provided a summary of some of the legislative proposals that the courts will be pushing at the Capitol next session.

The managers also received an update from CSA staff regarding ongoing analysis and conversations with the PSPRS Board of Trustees about the actuarial assumptions used by the plan. The group discussed the on-going funding problems associated with PSPRS/CORP/EORP as well as how to better educate policy makers about the problem. Staff also briefed the group on two resolutions that will be brought to the CSA Board of Directors next week—one dealing with increased investment in Arizona fish hatcheries and another opposing the transfer of Colorado River water allocated to river communities away from those communities.

Other topics of discussion included potential issues surrounding the implementation of the Workforce Innovation and Opportunities Act, PTSD and workers' compensation issues, the prospect of finding an alternative funding source for Interstate 15 in northeast Arizona, abandonment of state roads and highways to the counties, and the CSA legislative proposals.

## House Ad Hoc Committee on Earned Release Credits for Prisoners



On Monday, August 9, 2019 the nine-member House Ad Hoc Committee on Earned Release Credits for Prisoners (Committee) met. The Committee is charged with studying, gathering input and establishing recommendations regarding the earned release credit system for prisoners.

The Committee heard testimony from a variety of stakeholders including the Arizona Justice Project, Maricopa County Attorney's Office, Pinal County Attorney's Office, the Arizona Board of Executive Clemency, Arizonans for Rational Sex Offense Laws and FWD.us.

The Chairman indicated that there will be a total of seven bills drafted for the Committee to review. He is also recommending the creation of a criminal justice task force that is not part of the legislative body to look at the criminal justice system and an independent audit of the Arizona Department of Corrections.

The next committee meeting is scheduled for Monday, September 23, 2019; it will be an open meeting for individuals or family members of individuals who have been in the criminal justice system and victims to share their perspectives.

Committee members include: Representative Walt Blackman, Chairman; along with Representatives Reginald Bolding; Shawna Bolick; Domingo DeGrazia; Diego Espinoza; Tony Rivero; Bret Roberts; and Diego Rodriguez.

## Wildfire Update

County leaders continue to work hard to ensure that proper resources are deployed to protect public safety during a fire. There are currently three wildfires burning in Arizona, including:

- Sheridan Fire – The Prescott and Tri-City area fire is currently 21,510 acres. The fire is reported as being 60 percent contained, but decreased fire activity has reduced updates on the overall fire operations.
- Eden Fire – The lightning caused wildfire is burning northeast of Clints Well. The 1,750 acre fire is being used to clean up forest fuel and is about 30 percent contained.
- Whiskey Fire – The 140 acre fire burning east of Turkey Butte Lookout in Coconino County is within the 2014 Slide Fire burn area. Forest roads near the fire are expected to be closed through the end of the week to allow firefighters access to complete their operations safely.

## Flu Season is Here: Get Your Flu Shot!

The Centers for Disease Control and Prevention (CDC) recommends a yearly flu vaccination as the first and most important step in protecting against flu viruses. It is strongly recommended that everyone 6 months old and older get a flu shot each year.

The following groups should get a flu vaccination because they are at high risk of having serious flu-related complications or because they live with or care for people at high risk for developing flu-related complications, including:

- Pregnant women
- Children younger than 5, but especially children younger than 2 years old
- Children with special healthcare needs
- People 50 years of age and older
- People of any age with certain chronic medical conditions
- People who live in nursing homes and other long-term care facilities
- People who live with or care for those at high risk for complications from flu, including:
  - Health care workers
  - Household contacts of persons at high risk for complications from the flu
  - Household contacts and out of home caregivers of children less than 6 months of age (these children are too young to be vaccinated)



Flu symptoms include fever, chills, muscle aches, cough, congestion, runny nose, headaches and fatigue. Complications of flu can include bacterial pneumonia, ear infections, sinus infections, dehydration and worsening of chronic medical conditions, such as congestive heart failure, asthma, or diabetes and can cause death.

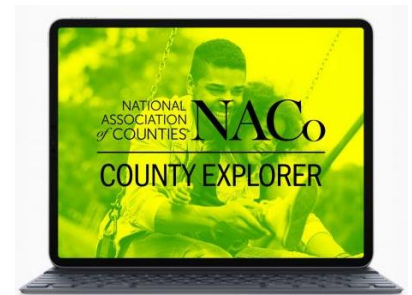
